

Our November at St. John's begins with Totenfest Sunday, during which we remember with thanks and prayers those who have died in the past year. Another name for this is **All Saints Sunday**, which calls us to remember those who have died as well as celebrate "the Communion of Saints". Saints are those made holy by Jesus. All of us who are loved by Jesus are saints – even me, even you! We celebrate our unity with saints past, present and future. Family members of the deceased will receive a white rose from the altar.

In November, I will be privileged to preach two Sundays:

November 17 – We will observe Thanksgiving Sunday.

November 24 – We will celebrate "Christ the King" as our church year draws to a close and we look forward to Advent and Christmas.

Sing with our choir for two months? Please consider singing with us for the two holiday months. Our choir music is not difficult and is faith building. The choir brings blessings to the congregation. After the two months, you are free, without guilt, to return to your place down in the congregation.

Plan now how you will observe Advent. It's a month away. Carve out some time from your very busy December and grow in faith and service to Jesus, whom it is all about. Prayer time? Reading? Sharing? Caring for someone else? Extra offering? Extra serving and helping?

Here are some things I have been thinking about: It would be nice to say the **Apostles' Creed** (and/or one of the other creeds in our hymnal) at worship, at least from time to time. I would like to have an Evening Prayer Service (**Vespers**) in our chapel occasionally. It would be refreshing to **vary our Sunday order of service** once in a while. What do **you think** about these things?

Some thoughts on our annual meeting, November 10: Remember we are doing the church's business. We are looking at how we best can serve our Lord Jesus as a church family. Our consideration should be what is the most faithful, helpful and best way to be the church in this time and place. We are united in love. We also should be thankful and supportive of the thought, work, and time that the Lead Pastor and Church Leaders have given in the past year and to prepare budget and reports. We are called by God to be kind and gentle, even we disagree or we present our own thoughts on matters. These are some thoughts from one of your pastors – **me!**

I want to confess that I haven't done so much home visitations this month (October). In as much as I wanted to, but to no avail. Let's not forget that prayer is the power of God in the hands of the faithful.

Council Minutes
St. John's United Church of Christ
October 14, 2019
(Rescheduled from October 10, 2019)

This meeting was rescheduled as a result of a number of council members being unavailable on October 10, 2019.

Present: Adam Wirrig, Douglas Goudy, Chris van Breukelen, Ballard Yates, Patty Staley, Bill Smith, Karen Clark and Pat Kern.

Guest(s): None

The meeting was called to order by Vice President Chris van Breukelen at 06:07 p.m.

Devotions: Doug Goudy presented the opening devotions and prayer.

Secretary's Report: Ballard Yates had e-mailed and distributed both the minutes of the special council of September 8, 2019, and the regularly scheduled council meeting of September 12, 2019. As there were no additions or corrections for either set of minutes submitted, he asked they be approved. Vice President Chris van Breukelen declared them approved.

Additional Information

There were two items that required immediate attention in the interim period between the September 12, 2019 council meeting and this October 14, 2019 meeting. For transparency, they are listed below.

Office Copier

Several council members had been reviewing the status of our current equipment. Our copier is approximately five years old, was becoming very expensive to use and maintain, as well as being out of date. It was under review to be replaced when it was discovered that our current contract would automatically renew on October 31, unless we gave a 30 day notice of cancellation. In accordance, notice of cancellation was given to that vendor on September 25th, and a new machine ordered from a different vendor on September 26. This action will result in a more advanced machine at a lower total cost. Prior to these actions, all council members received detailed information electronically on this situation, and an electronic vote was taken whether to proceed. The vote was unanimous to proceed with these actions.

Exterior Painting Contract

As a result of our original painting contractor cancelling the contract, Bill Smith contacted seven painting contractors for bids, but only three chose to bid. These bids were shared with all council members, and the contractors investigated. One was selected, and Bill Smith and Brian Dunkle walked the property with the contractor to be sure that the company was aware of requirements and expectations. While this task is weather dependent, the contractor believes they can complete it this fall. Building and Property will monitor the project to assure that the contractor is working on all available days. With good weather coming to a close, it was in the church's interest to begin work on this project as soon as possible. Accordingly an electronic vote was taken, as to whether to proceed. The vote was unanimous in favor of proceeding.

Financial and Treasurer's Report:

As Isaiah Ashba was unable to attend due to employment requirements, Patty Staley and Rev. Adam Wirrig gave the Treasurer's report.

Work continues on implementation of the new Realm accounting software, with additional accounts being added, and some "fine tuning" and minor adjustments being made as required.

September experienced heavy expenditures, primarily due to regular maintenance, and large billings for taxes, health care, pensions etc. from the denomination. The U.C.C.'s original plan was to do this monthly, but they are still trying to catch up for items they had not invoiced.

Rev. Adam Wirrig reported that since we are now making monthly payments on our loan, he is pleased to report that the church is receiving contributions toward these payments from the congregation. Of course the congregation will need to continue this practice.

Budget and Finance will probably sell \$15,000 of asset investments to cover any shortfall of liquidity in the last quarter of the year. This was included in last year's authorization.

Ballard Yates made a motion to approve the Treasurer's Report which was seconded by Doug Goudy and approved by vote of the church council.

Old Business

Dish Washer Project

The church council's vote on this project scheduled for tonight has been delayed. The timing for the meeting with the parties involved was rescheduled due to schedule conflicts.

Building of Committees

This item will be an ongoing monthly item. A report was distributed this evening (with some handwritten additions) indicating the individuals filling the various positions—Officers (“The Executive Committee”), Team Leaders, and Team Members. All positions are filled with the exception of two team members who have not confirmed their acceptance as of tonight’s meeting. Patty Staley made a motion to place this slate of Officers, Team Leaders, and Team Members for approval and ratification in the Annual Report Booklet. It was seconded by Karen Clark and confirmed by vote of the Church Council.

New Business

Building and Property

Bill Smith advised that the circulating pump for the heating system has not yet been returned and he is not sure of the cost for repair. He will keep us advised.

He also announced ECO Restorations has been awarded the contract for the outside painting of our church property.

Bill Smith made a comment that we really need to consider painting and doing a general “clean up” of the upper floor of the educational building. It is in definite need.

Bill Smith would like to see St. John’s move toward having a professional review of our physical building once a year. This would keep us advised of upcoming items needing repair or replacement and reduce the sudden unanticipated emergency repairs which we have often experienced.

2020 Budget

Karen Clark made a motion that we provide an item to set aside \$45,000 from the Endowment Fund for 2020 to fund the deficit if required. It was seconded by Doug Goudy and approved by vote of the council.

Patty Staley and Adam Wirrig presented the proposed budget, offering explanations of the various line items. Karen Clark made a motion to accept the budget for 2020 which was seconded by Doug Goudy and approved by vote of the church council.

November Congregational Meeting

Rev. Adam Wirrig made a motion to place a copy of the proposed St. John's UCC Member Covenant in the Annual Report Booklet. On approval, this will become a portion of our "new" constitution which will go into full effect as of January 1, 2020. It was seconded by Doug Goudy and approved by vote of the Church Council.

President Doug Goudy presented the agenda for the annual Congregational Meeting to be held, following the Worship Service, on November 10, 2019 at 11:30 A.M. Patty Staley made a motion to accept the agenda which was seconded by Pat Kern and approved by vote of the Church Council.

Doug Goudy will ask Bill Smith to act as Parliamentarian at the annual meeting as he is familiar with Robert's Rules of Order.

Committee Reports Received

The following Individuals and Committees submitted written reports: Vice President, Building and Property, Worship, and Lead Minister.

Items for the Good of the Order:

We continue in our efforts to secure transportation for Jan Zahn to attend our worship service. The possibilities suggested unfortunately seem to be people who have to arrive very early because of other St. John's commitments.

AED Defibrillator/Security. Doug Goudy will have an update at the November meeting.

Adjournment

Patty Staley made a motion that the meeting be adjourned which was seconded by Chris van Breukelen and approved by vote of the council.

Closing

The meeting was closed with all praying the Lord's Prayer.

Krogers assigned St. John's a new number for the Community Rewards Program.


This new number is **WD765**.

Instructions for signing up as a new Community Rewards member are in the Church office.


